In consideration for receiving this air transportation, we agree to hold harmless Wings for Children, Flight Division. To assume all risk of damage or injury, including death, however caused, whether by negligence of the pilot(s), owner(s) or otherwise, while in or about the plane, and agree that accomplishment of the objective of flight is not guaranteed; neither they nor their heirs will make any claim against or sue Wings for Children, Flight Division, pilot(s) or plane owner(s) from all claims that they or their heirs may have for any of the foregoing, however caused, whether by negligence of the pilot(s) or owner(s) or otherwise, and waive all rights, claims and causes of action against Wings for Children, Flight Division, pilot(s) and plane owner(s). To hold harmless and indemnify Wings for Children, Flight Division, pilot(s) and plane owner(s) from all loss, liability, damage or costs incurred because of any claim made or lawsuit brought relating to the intended transportation, whether based on negligence of the pilot(s) or owner(s) or otherwise.

The above agreement to Wings for Children, Flight Division, includes its members, directors, officers, employees and volunteers.

In the event any portion of this contract is held invalid, the other sections shall remain in full force and effect.

This waiver is governed by the laws of South Carolina.
